Hearings Held in Annapolis on SB150/HB6: Maryland Medical Assistance Program – Dental Coverage for Adults Compelling Testimony from Legislators, Advocates, Family Members, and Patients



On January 25 and February 9, the Senate Finance and House Health & Government Operations Committees held hearings on legislation that would mandate comprehensive adult dental coverage in Maryland's Medicaid program. The bills, introduced by oral health champions Senators Malcolm Augustine (D-Prince George's County) and Guy Guzzone (D-Howard County) and Delegates Bonnie Cullison (D-Montgomery County) and Mike McKay (R-Allegany and Washington Counties) would bring the State of Maryland in line with 47 other states that include adult dental health care in its Medicaid coverage.

United States Senator Benjamin Cardin opened the Senate Finance Committee hearing with powerful testimony underscoring how the legislation would help the thousands of low-income Maryland residents improve their oral and overall health, prevent emergency department visits for non-traumatic dental conditions, and break down the barriers to employment caused by poor oral health.

Senator Cardin's presentation was followed by over 30 compelling verbal testimonies from patients, family members and advocates who described situations ranging from fatal drug overdoses due to chronic pain to detrimental quality of life to excessive and costly medical bills due to untreated dental care and lack of access. There was no verbal testimony offered in opposition to the bill. In addition, scores of written testimonies in support of the legislation were also submitted by MDAC members, partners, and stakeholders statewide.

On February 1, the Baltimore Sun published an editorial, <u>Expand Medicaid to Cover Adult Dental in</u> <u>Maryland</u>, that effectively captured the Senate Finance Committee hearings, addressing the myriad of reasons why oral health is critical to the wellbeing of Maryland's adult population and how adult dental coverage in Maryland Medicaid would be a significant step to dismantling health disparities experienced by many across the state.

On February 11, bipartisan sponsors of SB150/HB 6 legislation once again collaborated to pen a commentary for <u>Maryland Matters</u> on why this bill is so critical to the wellbeing of Marylanders and could change the lives of hundreds of thousands of residents for the better.

MDAC Broadens Advocacy Base

To strengthen its advocacy efforts prior to the hearings, MDAC focused on broadening its stakeholder base to include organizations that facilitate and support the well-being and independence of Maryland adults. As a result, over 60 statewide, community, and grassroots organizations in Maryland pledged support for expanding adult dental in Maryland Medicaid by <u>signing the document</u> on the MDAC website.

Journal of Public Health Dentistry Highlights Study: Preventive Care Linked

to Better Health Outcomes

Routine Dental Care Lowers Dental Related Costs, ED Visits, and Pain Prescriptions

A study featured in the January 2022 issue of the **Journal of Public Health Dentistry** found that regular preventive dental visits were associated with improved healthcare outcomes. The study examined 186,000 Medicaid-eligible individuals compared to those who did not receive preventive dental visits and followed them for a 5-year period. The results determined that those who received routine preventive dental care had lower dental care costs, reduced emergency department visits for non-traumatic dental conditions, fewer dental-related opioid prescriptions and fewer oral surgeries than those who did not receive routine dental care.

Providers, Patients Acknowledge Benefits of Teledentistry Survey Reveals Acceptance of Teledentistry is Growing in the Oral Health Field

During the COVID-19 pandemic, providers, patients, and the health care system itself benefited from the use of telehealth and teledentistry, with many oral health providers incorporating teledentistry into their practices. Recently, the CareQuest Institute for Oral Health conducted a series of surveys of dental team members from Advantage Dental Oral Health Center in Oregon and Washington. The surveys explored how attitudes toward teledentistry changed over the course of six months as providers gained experience with virtual workflows and new software within the practices. What successes and challenges did they uncover? How have their perceptions of teledentistry evolved? Prior to



implementation of teledentistry, nearly a third (32%) of respondents thought that the quality of care given to patients would decrease with the use of teledentistry. Following six months of teledentistry implementation: more than three-quarters (76%) of respondents believed that utilizing a teledentistry platform increased access to care for patients. Approximately half of respondents agreed that utilizing a teledentistry platform increased patient satisfaction (51%) and helped shorten patient wait times to get an appointment (47%). Almost 85% of respondents said dentistry was ready to accept teledentistry as a care delivery method.

The survey results show that providers are open to teledentistry, and that it can play a crucial role in increasing access to care and improving quality of care. Read the CareQuest Institute for Oral Health report, **Oral Health Professionals Are Ready to Accept Teledentistry**.

MDAC has long recognized the critical role that CHWs playin helping individuals navigate pathways to good health. They work with individuals in their homes to improve health behaviors, address social determinants of health, and facilitate access to needed services. They also conduct workshops to help individuals manage chronic diseases and participate in outreach events to educate the public on the benefits of good health behaviors. CHWs provide a critical link to better health, working in health departments, clinics, senior centers, hospitals, area health education centers, and community organizations. The job of a community health worker requires core competencies including cultural humility; strong communication, interpersonal, observational, and organizational skills, and a solid foundation in care coordination, health education, outreach, and capacity building.

Thousands of Maryland adults are accessing dental care through the Medicaid Adult Dental Waiver Program.

According to Maryland Medicaid, from January 1, 2022 through February 8, 2022:

- 580 claims were submitted
- · 511 unique members filed valid claims
- 4 members met annual \$800 cap
- · 222 unique providers submitted claims
- \$100,734.76 paid

From January 1, 2021 through December 28, 2021:

- 8,970 claims were submitted
- · 4,447 unique members filed valid claims
- 361 members met annual \$800 cap
- · 591 unique providers submitted claims
- \$1,392,685.08 paid

From January 1, 2020 through December 31, 2020:

- · 7,942 claims were submitted
- 4,151 unique members filed valid claims
- 313 members met annual \$800 cap
- 576 unique providers submitted claims
- \$1,286,280.60 paid

Since the launch of the Medicaid Adult Dental Waiver Program, Medicaid has paid **\$4,092,448.69** in dental services for thousands of Maryland adults.
