MDH PROPOSES REGULATIONS FOR ADULT DENTAL WAIVER PROGRAM Public comment period now open

On January 4, the Maryland Department of Health (MDH) published proposed regulations for the Medicaid adult dental waiver program, bringing it one step closer to implementation. The proposed regulations outline the parameters of the program including:

- Who is eligible: All adults, between the ages of 21 and 64, who are dually eligible for Medicaid and Medicare.
- What services will be provided: Limited and comprehensive oral examinations, X-rays, prophylaxis, amalgam and resin restorations, and extractions (see proposed regulations for details).
- Dollar amount of services: Services will be capped at \$800 annually.

Once the Department reviews public comments and receives federal approval for the program, the final regulations will be published. We are excited to begin this program which will reach about 38,000 adults across Maryland who would otherwise have no dental coverage.

CARDIN SEEKS TO EXPAND MEDICARE TO INCLUDE DENTAL BENEFITS Introduced legislation to add dental benefit under Medicare Part B

U.S. Senator Ben Cardin (D-MD), a member of the Senate Finance Health Care Subcommittee, has introduced legislation (S. 22) that creates a dental benefit under Medicare Part B. Currently, Medicare does not pay for routine oral health care like checkups, cleanings and X-rays, restorative procedures, or dentures. Such care could help lower incidents of tooth loss and gum disease in older Americans. According to the Centers for Disease Control and Prevention (CDC), nearly one in five adults over the age of 65 have lost all of their teeth. About two in three (68 percent) adults aged 65 years or older have gum disease.

"Good oral health is essential to overall health, but quality oral care can be expensive – essentially out of reach – for too many people in Maryland and around the nation," said Senator Cardin. "We've made incredible progress expanding dental coverage to children, now we must do the same for the older Americans across this country."



An estimated 70 percent of seniors lack or have limited dental insurance, and fewer than half access dental care each year, according to the **Wisdom Tooth Project** of Oral Health America. The gap in coverage leads to high out-of-pocket costs for those who do access dental care.

The text of the Cardin legislation (S. 22) can be found here. The bill would repeal the statutory exclusion on Medicare coverage of dental care and dentures in Section 1862(a)(12) of the Social Security Act. The legislation expands Part B benefits to cover dental and oral health services, including routine cleanings and exams, fillings and crowns, major services such as root canals and extractions, emergency dental care, and other necessary services.

In September of last year, Senator Cardin led his colleagues in a bipartisan letter to the Department of Health and Human Services urging Secretary Azar to use existing authorities to improve Medicare coverage for adult oral health to improve oral health and overall wellness as well as potentially reduce costs to the Medicare program. Cardin was also responsible for guaranteeing pediatric coverage for dental care through both the Children's Health Insurance Program (CHIP) and the Affordable Care Act (ACA).

The Cardin dental health bill has <u>earned endorsements</u> from Families USA, Justice in Aging, Center for Medicare Advocacy, and Oral Health America. MDAC strongly supports a Medicare dental benefit.

ACTION FOR DENTAL HEALTH ACT SIGNED INTO LAW Bill reauthorizes oral health promotion and disease prevention programs through 2022

The Action for Dental Health Act, a bill that reauthorizes oral health promotion and disease prevention programs, was signed into law on December 11, 2018.

The legislation amends the Public Health Service Act to provide \$32 million in funding for oral health and disease prevention programs each fiscal year through 2022. It also expands the eligibility of the types of organizations that can apply for Human Health and Services (HHS) grants to establish outreach programs to help those in underserved communities access dental care and establish a dental home.

Beth Truett, president and CEO of Oral Health America, a major proponent of the bill, said, "This legislation is encouraging and signals oral health is a priority of Congress. Increasing oral health education and preventive oral health programs will be key to improving early diagnosis, intervention and prevention programs for our communities."

POLICY BRIEF ON ORAL HEALTH IN RURAL AREAS RELEASED

Outlines policy recommendations to remove barriers to care in rural areas



The National Advisory Committee on Rural Health and Human Services recently released *Improving Oral Health Care*Services in Rural America, a policy brief that outlines the barriers to oral health care access faced by many in rural areas.

Issues such as lack of providers willing to work in rural areas, lack of transportation, the capital needed to start a rural practice, specialization in dental care, and the large number of dentists predicted to retire in the near future impact the oral health of rural residents.

The brief provides an overview of federal efforts to remove barriers to care and offers recommendations to improve the oral health status of rural Americans.

SURGEON GENERAL TO RELEASE REPORT ON ORAL HEALTH IN 2020 CDC and NIDCR seeking stakeholder input

The Centers for Disease Control and Prevention (CDC) and the National Institute on Dental and Craniofacial Research (NIDCR) are seeking input to guide the development of the new Surgeon General's Report on Oral Health, to be issued in 2020. The U.S. Department of Health is seeking written comments on the proposed objectives for Healthy People 2030, a set of national health targets focused on critical public health priorities, health promotion and disease prevention. The objectives will be used to guide efforts to improve the health of all Americans.

SURGEON GENERAL RELEASES ADVISORY ON E-CIGARETTE EPIDEMIC

E-cigarette use among youth skyrocketing; up more than 75% between 2017 and 2018

On December 18, 2018, U.S. Surgeon General Vice Adm. Jerome M. Adams issued an advisory stressing the importance of protecting children from a lifetime of nicotine addiction and associated health risks by immediately addressing the epidemic of youth e-cigarette use.

E-cigarette use among youth has skyrocketed in the past year at a rate of epidemic proportions. According to data from the Centers for Disease Control and Prevention and the Food and Drug Administration's National Youth Tobacco Survey, the percentage of high school-age children reporting past 30-day use of ecigarettes rose by more than 75 percent between 2017 and 2018. Use among middle school-age children also increased nearly 50 percent.

Data from National Institutes of Health's Monitoring the Future survey also shows that America's teens reported a dramatic increase in their use of e-cigarettes in just a single year, with 37.3 percent of 12th graders reporting use in the past 12 months, compared to 27.8 percent in 2017.

"We need to protect our kids from all tobacco products, including all shapes and sizes of e-cigarettes," said Adams. "Everyone can play an important role in protecting our nation's young people from the risks of e-cigarettes."

The surge in e-cigarette use among our nation's youth has been fueled by newer cartridge-based devices that have become increasingly popular. Many of these e-cigarettes look like a USB flash drive, making them easy to conceal. One of the most commonly sold versions is JUUL, which now has more than a 70 percent share of the cartridge-based e-cigarette market in the United States. A typical JUUL cartridge, or "pod," contains about as much nicotine as a pack of 20 regular cigarettes.



"In the data sets we use, we have never seen use of any substance by America's young people rise as rapidly as e-cigarette use is

rising," said HHS Secretary Alex Azar. "Combustible cigarettes remain the leading cause of preventable death in the United States, and providing an effective off-ramp for adults who want to quit using them is a public health priority. But we cannot allow e-cigarettes to become an on-ramp to nicotine addiction for younger Americans. HHS has been and will continue developing a comprehensive, balanced policy approach to this challenge."

As noted in the 2016 Surgeon General's report on E-cigarette Use Among Youth and Young Adults, e-cigarette use poses a significant – and avoidable – health risk to young people. Besides increasing the possibility of addiction and long-term harm to brain development and respiratory health, e-cigarette use may also lead to the use of regular cigarettes that can do even more damage to the body.

"We have evidence-based strategies to prevent tobacco use that can be applied to e-cigarettes." said Adams. "We must take action now to protect the health of our nation's young people."

MD SELECTED FOR INTERPROFESSIONAL COLLABORATION PROJECT OHRC Partnership for Integrating Oral Health Care into Primary Care

The National Maternal and Child Oral Health Resource Center (OHRC) at Georgetown University announced that five states—Georgia, Illinois, Maryland, Michigan, and Rhode Island—have been selected to participate in the Partnership for Integrating Oral Health Care into Primary Care project.

OHRC will work with state Title V maternal and child health agencies and local primary care settings to integrate the interprofessional oral health core clinical competencies into practice. Primary care health professionals will integrate oral health care into primary care by completing risk assessments and screenings, providing preventive interventions and oral health education, and conducting interprofessional collaborative activities. The populations of focus include pregnant women, infants, children, adolescents, and young adults. Project settings include community health centers, a local public health department, and a university-based women's health clinic.



The 2018-2023 Maryland Oral Health Plan outlines 11 oral health goals in three key areas:

Access to oral health care:

- All Maryland children have comprehensive dental insurance coverage through public (Medicaid/MCHP) or private insurance.
- All Maryland adults have comprehensive dental insurance coverage through Medicaid or private insurance.
- All Maryland residents have a dental home.
- Strengthen the oral health safety net provider system.
- Integrate the oral health care system within the medical health care system.

Oral disease and injury prevention:

- Use data to advance optimal oral health for all Marylanders.
- Improve public awareness of oral disease and injury prevention.
- Promote community-based oral disease and injury prevention programs.

Oral health literacy and education:

- Increase understanding of the relationship between oral health and overall health, and promote good oral health practices and access to oral health care.
- Improve collaboration between oral health and other health and human services providers so that patients understand how to navigate the oral health care system and establish a dental home.
