Chalmers to Present Emergency Department Study Results at December 4 MDAC Members' Meeting

Through the Maryland General Assembly's unanimous support of Senate Bill 169, the Maryland Dental Action Coalition (MDAC) is conducting a study to evaluate the cost of emergency department visits for adults with chronic dental conditions, and to assess whether state funds can be reinvested to establish an adult dental benefit in Medicaid. The study will be submitted to the Maryland General Assembly and the Maryland Department of Health by December 1, 2017.

MDAC will host a webinar on Thursday, November 9 to get member input on both the methodology of the study and how the study can support our advocacy efforts. The study is a key strategy in our collective efforts to establish an adult dental benefit in Medicaid. Its findings will likely demonstrate that Maryland should reinvest funding from ER visits into Medicaid adult dental benefits. Webinar invites will be sent out soon.

Natalia Chalmers, D.D.S., Ph.D., Director of Analytics and Publication for the DentaQuest Institute, is leading the study and will present her findings at the December 4 MDAC members' meeting, to be held at MSDA in Columbia. All members are encouraged to attend.

MDAC and its coalition partners across the state strongly advocate for Medicaid coverage of adult dental services. We hope to gain the support of Governor Larry Hogan so Maryland can ensure low-income adults have access to affordable oral health care.

MDAC Spotlight: Allegany County Health Department Dental Clinic

MDAC is so impressed with the many efforts statewide to improve the oral health of Marylanders that we just have to share them! This month the spotlight is on western Maryland. Director of Dental Health Gretchen Seibert, D.D.S., M.A.G.D., provided this report on the Allegany County Health Department Dental Clinic:

Several new developments are under way at the Allegany County Health Department Dental Clinic. In our fifth month of MCHRC-funded Adult Urgent Dental Care initiative, we provide two innovative programs. The first is an emergency department diversion program for patients who report to the Western Maryland Hospital System Emergency Department for dental complaints. They are referred to ACHD for definitive dental care delivered within 48 hours. As of October 1, over 125 patients have received extractions for toothaches causing facial

swelling, temperature, extreme pain, and lost work time. We have treated over 44 patients that walked directly to our clinic from the ED. A second portion of the grant funds supports dental appointments for senior citizens who attend HRDC Senior Centers in Allegany County. Our first Elder Care Day yielded seven patients in need of denture adjustments, two in need of extractions, and one in need of a cleaning. Four patients were veterans of our armed forces that had been unable to obtain dental care for decades.

In collaboration with AHEC West's HRDC Mountain Health Alliance grant, we have provided ten sets of complete dentures to edentulous patients in less than one year. These patients report increased self-esteem and several have obtained employment after long periods out of the workforce.

Our dentists have adopted promising new techniques and procedures through frequent continuing education courses. One such technique is the use of Silver Diamine Fluoride. This new SDF procedure provides caries control, preventing unnecessary hospital-based dental care, and the ability to treat our most vulnerable patients.

We continue a robust partnership with Allegany Health Right to provide non-urgent comprehensive dental care services to adults who are uninsured or underinsured. We have provided services to 52 patients at this point only 3 months into FY18 from direct referral through Allegany Health Right.

Sugar Free Kids Looking to Make Kids' Meals Healthier

This past Monday, Council Member Brandon Scott introduced the Baltimore City Healthy Kids' Meals Bill to the Baltimore City Council. The bill is supported by Sugar Free Kids and the Baltimore City Health Department.

The proposed legislation would make water, milk, and 100% fruit juice the default beverage option for all restaurants kids' meals in the city of Baltimore. The bill will improve health for Baltimore City families by improving healthy dining options. Families would be able to order other beverage items upon request.

Busy parents with limited options are often faced with the need to eat out on a regular basis with their families. The default options for kids' meals in restaurants are almost always sugary drinks. Mayor Pugh and the Baltimore City Council have the opportunity to ensure that healthy choices will be available to city families so that their children can have better opportunities to live long, healthy lives, free of chronic disease.

The children of Baltimore City are developing chronic diseases such as type 2 diabetes, tooth decay and hypertension at alarming rates. The prime contributing factor to these problems is the over-consumption of sugary drinks.

One in four Baltimore children drink at least one soda every day, well over the American Heart Association's recommendation that children over the age of 2 only drink one 8 oz. sugary drink a week.

CHIP Funding Expires; Executive Orders Threaten Access to Care

Two executive orders announced last week and the expiration of funding for the Children's Health Insurance Program (CHIP) threaten to destabilize the insurance markets and leave millions of Americans without access to health or dental coverage.

The following report on actions affecting health care is from Families USA, Children's Dental Health Project, Oral Health America, Community Catalyst, and Center for Medicare Advocacy:

Late last week, the administration made the decision to cease the ACA's Cost Sharing Reduction (CSR) payments and issued an Executive Order regarding the individual and small group markets, both of which could undermine our health care system and oral health coverage.

On Thursday, the President announced that the federal government will no longer fund CSR payments to reduce deductibles and out-of-pocket costs for low-income marketplace enrollees. This will increase premiums for millions of Americans, making health coverage unaffordable for many. The decision may also lead to insurers pulling out of marketplaces in states throughout the country.

The President also issued an Executive Order on Thursday that urges the Departments of Labor and HHS to issue rules that would loosen restrictions on "association health plans" and "short-term health plans". Unrestricted, these low-cost and low-coverage plans weaken market

stability, making more comprehensive coverage unaffordable. They could also undercut important Affordable Care Act (ACA) protections including Essential Health Benefit requirements, which protect pediatric oral health coverage, as well as safeguards for people with pre-existing conditions, and other standards to ensure coverage meets people's needs.

With these developments, Congress should be focusing on action to fund CSRs and to fund the Children's Health Insurance Program—the deadline for which passed over two weeks ago—and other efforts to stabilize and improve health coverage.

ASTDD Seeks State Activities Submissions for New Best Practice Approach Use Report

The Association of State and Territorial Dental Directors (ASTDD) Fluorides and Best Practices Committees are calling for State Activity Submissions from state/territorial/community oral health programs and their partners for a new Best Practice Approach Report (BPAR) Use of Fluoride: School-Based (K-12) Programs. The new BPAR report will address the various fluoride products used in school settings.

The intent is to create a useful resource for state oral health programs and stakeholders that includes a collection of promising and best practice examples from state/territory programs including guidelines, recommendations, evidence, and field examples. ASTDD is looking for examples that provide "real" and "practical" information about programs in K-12 schools that provide topical fluorides such as fluoride varnish, silver diamine fluoride, and fluoride mouth rinse; fluoride supplements; fluoridated school water supplies; and brushing programs using fluoride toothpaste.
